13 MILES (FAMILY ROUTE)
OUT ROUTE 30 TO THE COVERED BRIDGE

32 MILES (MID-LENGTH ROUTE)
UP ROUTE 30 PAST NEWFANE, ACROSS THE RIVER,
PAVED BROOKLINE LOOP AND BACK TO START.

60 MILES (ALMOST A METRIC CENTURY!)
PAVED BACK ROADS THROUGH GUILFORD, LEYDEN, GREENFIELD, TURNERS FALLS,
MONTAGUE, MILLERS FALLS, NORTHFIELD, GILL, VERNON AND BACK TO START.

Group start times are 8:30 a.m. for 60 miles, 9 a.m. for 32 miles and 9:30 a.m. for 13 miles.
Map and cue sheets for each ride will be provided at check-in. Sag stops are located at Dummerston covered
bridge, Brookline School, Greenfield High School and Northfield Mountain Visitor Center.
